As a child or youth in care
you have certain rights that
must be given to you.
These rights can not be
taken away from you.

I have the right to...



You always have your rights no
matter how well you are
meeting your responsibilities.

Your worker should regularly
review your rights with you,
while you are in care with us.

- Know and understand my rights
- Be and feel safe
- Be treated fairly no matter my race, sex, culture, religion, abilities, or sexual orientation
- Have a say about what happens to me (i.e. education, community & cultural identity, placement, etc.)
- Receive mail & send written or electronic communications
- Express my thoughts and feelings
- Be properly fed, clothed and cared for
- Go to school
- Receive medical and dental care
- Participate in social and recreational activities
- Participate in religious and cultural events that are important to me
- Speak my language
- Have access to an interpreter
- Reasonable privacy & possession of my own personal belongings
- Know and understand the rules, expectations and responsibilities of the home in which I live
- Speak privately and visit with members of my family and extended family.
- Talk privately with my worker, a lawyer, the Ombudsman, a Member of Parliament or an Advocate

IF IT'S WRONG, RIGHT IT!

IF I AM OVER 12 | I also have the following rights...

- Attend court and know what decisions are planned for me
- Ask to have a review or an appeal of my placement
- Help develop my plan of care

IF I HAVE BEEN CHARGED WITH A CRIMINAL OFFENCE | I also have the following rights...

- Know why I have been arrested
- To have legal representation
- Remain silent and contact a lawyer
- Call a lawyer and a parent or someone I trust
- The telephone number for a lawyer
- Have a lawyer represent me
- Ask the Custody Review Board to review decisions regarding my care



AS A CHILD OR YOUTH IN CARE | I also have some responsibilities...

- Let my foster parents know my plans
- Keep in contact with my worker
- Attend school and do my homework
- Attend all my appointments
- Respect other people and their property
- Respect others' privacy
- Respect other people's differences
- Take care of myself / my body
- Be helpful to others and do my share (of chores)
- Take responsibility for my actions / of what to do
